

SUBJECT: Approve the request made by the Chiriaco Summit Water District to perform biennial audits permitted under Government Code 26909(b)(1) (Requires unanimous vote)

RECOMMENDED MOTION: That the Board of Supervisor approve by unanimous vote the request made by the Chiriaco Summit Water District to perform biennial audits permitted under Government Code 26909(b)(1)

BACKGROUND:

Request

The Chiriaco Summit Water District (District) requests authorization to conduct a biennial audit, permitted under Government Code 26909 (b) (1) with unanimous approval by the District and the Board of Supervisors. If approved, this request will be granted so that the District's next audit will be competed for the fiscal years ended June 30, 2016 and June 30, 2017. The District will then be required to file on a biennial basis from that point on.

Justification

The Chiriaco Summit Water District is a small special district with limited resources. Professional audits are expensive and divert scarce resources away from direct services to administrative overhead. With approximately \$200,000 in annual revenue, a biennial audit would allow the District to utilize more resources on mission-related services while providing sufficient financial accountability.

BACKGROUND:

About the District

Chiriaco Summit Water District was formed on May 9, 2000 under the provisions of the Municipal Water District Act of 1911 for the purpose of developing a domestic water supply for the area of Chiriaco Summit, CA. The District generates revenue from water sales. It does not receive property taxes and relies on part-time employees.

The District failed to perform annual audits for several years and suffered from some financial troubles. The District has improved its finances and has now filed annual audits with unmodified opinions for the last three fiscal years.

Re: Request to be placed on a biannual audit cycle

Honorable Supervisor Benoit:

The Chiriaco Summit Water District would like to submit to your consideration our request to be on a bi-annual audit cycle.

When our water district was formed in 2000, the Chiriaco Summit Water District did not receive any startup money or any other type of funding to meet the necessary expenses of the water district, including costly engineering and legal fees. Also, we do not receive any type of public funding or property taxes. Being one of the smallest districts in the state, we have to comply with all the federal, state and local regulations, including full time monitoring, and periodic laboratory analyses, just as any other district. We do all that and more with three employees and a board of directors that does not receive any kind of compensation.

As part of those requirements, we need to be audited each year, something that causes great stress to the district. When we resolved our situation regarding the pending audits in 2014, we began to look into not being out of compliance again, and the easiest way is to be placed into a bi-annual audit cycle – according to the independent CPA firm that worked in our audit for the past two years, we would pay \$8,000 for a bi-annual audit, compared to paying \$6,000 or more per year if done independently. That \$2,000 saved per year can go a long way in a small district like ours. Besides the multi-year audit performed in 2013, we have also completed two consecutive yearly audits, with no issues.

We ask you to please consider our request carefully, as the water district is very important to the existence of our small desert community, and to the traveling public.

1. Call to Order: Meeting was called to order at 10:03am JIVCO . 1 A

Also present were the District's Office Manager (Eduardo Guevara) and the Plant Operator (Hector Sanchez) All board members present, quorum was declared.

2. Old Business

- 2.1. Riverside County Auditor-Controller's Office The need to request unanimously to the County Board of Supervisors (BoS) to be placed in a bi-annual audit was re-briefed. All the board members agreed to present the request in writing to the BoS. Diana Ragsdale made a motion to approve the request, and was seconded by Mr. Chiriaco. All in favor, motion carried. Office Manager will draft the letter and when final, it will be signed by president Rusche and send along a copy of these minutes, when approved as final.
- 2.2. Water Loss Audit Preliminary Results: A Top-Down preliminary Water Loss Audit (WLA) was conducted by the office manager. Preliminary results show an estimate of 22%. Plant Operator presented the following possible causes for the discrepancy of 1 acre-foot (AF) in four months:
 - One unmetered connection for irrigation
- Construction use

- Evaporation
- Periodic flushing of the lines
- Fire hydrant

Treatment Plant backwash cycles (the more water is used, the more backwash/loss we will have)

Plant operator was requested to estimate as much as possible the figures for the flushing of the lines, the backwash and to install the meter in the unmetered connection, to proceed to calculate how much may be lost in evaporation and how much may be water unaccounted for. Office Manager will follow up. Heather Garcia recommended research on the price of meters for the fire hydrants.

Office Manager advised to have Jose Lemus certified should he needed to work further on the plant. Heather Garcia mentioned he needed to be added to the payroll if he would be working with the district.

4. PUBLIC COMMENTS:

- Plant Operator stated that Riverside County would perform an inspection of the treatment plant on June 3rd, and that Jose Lemus would be required to work for a couple of days. He was asked by Office Manager to follow up with him.
- Eduardo Guevara stated that he was made aware by one of the residents, that she would present the required
 documentation to run for one of the two available seats for the board.

BOARD RULES

Requests to Address Board on "Agenda" Items:

You may request to be heard on a published agenda item. Requests to be heard must be submitted to the Clerk of the Board before the scheduled meeting time.

Requests to Address Board on items that are "NOT" on the Agenda:

Notwithstanding any other provisions of these rules, member of the public shall have the right to address the Board during the mid-morning "Oral Communications" segment of the published agenda. Said purpose for address must pertain to issues which are under the direct jurisdiction of the Board of Supervisors. YOUR TIME WILL BE LIMITED TO THREE (3) MINUTES.

Power Point Presentations/Printed Material:

Speakers who intend to conduct a formalized Power Point presentation or provide printed material must notify the Clerk of the Board's Office by 12 noon on the Monday preceding the Tuesday Board meeting, insuring that the Clerk's Office has sufficient copies of all printed materials and at least one (1) copy of the Power Point CD. Copies of printed material given to the Clerk (by Monday noon deadline) will be provided to each Supervisor. If you have the need to use the overhead "Elmo" projector at the Board meeting, please insure your material is clear and with proper contrast, notifying the Clerk well ahead of the meeting, of your intent to use the Elmo.

Individual Speaker Limits:

Individual speakers are limited to a maximum of three (3) minutes. Please step up to the podium when the Chairman calls your name and begin speaking immediately. Pull the microphone to your mouth so that the Board, audience, and audio recording system hear you clearly. Once you start speaking, the "green" podium light will light. The "yellow" light will come on when you have one (1) minute remaining. When you have 30 seconds remaining, the "yellow" light will begin flash, indicating you must quickly wrap up your comments. Your time is up when the "red" light flashes. The Chairman adheres to a strict three (3) minutes per speaker. Note: If you intend to give your time to a "Group/Organized Presentation", please state so clearly at the very bottom of the reverse side of this form.

Group/Organized Presentations:

Group/organized presentations with more than one (1) speaker will be limited to nine (9) minutes at the Chairman's discretion. The organizer of the presentation will automatically receive the first three (3) minutes, with the remaining six (6) minutes relinquished by other speakers, as requested by them on a completed "Request to Speak" form, and clearly indicated at the front bottom of the form.

Addressing the Board & Acknowledgement by Chairman:

The Chairman will determine what order the speakers will address the Board, and will call on all speakers in pairs. The first speaker should immediately step to the podium and begin addressing the Board. The second speaker should take up a position in one of the chamber aisles in order to quickly step up to the podium after the preceding speaker. This is to afford an efficient and timely Board meeting, giving all attendees the opportunity to make their case. Speakers are prohibited from making personal attacks, and/or using coarse, crude, profane or vulgar language while speaking to the Board members, staff, the general public and/or meeting participants. Such behavior, at the discretion of the Board Chairman may result in removal from the Board Chambers by Sheriff Deputies.
