**RESOLUTION NO: 2024-2** 

## RESOLUTION AUTHORIZING CHIRIACO SUMMIT WATER DISTRICT TO PROCEED WITH THE IMPLEMENTATION OF A UNIFORM RATE STRUCTURE ASSOCIATED WITH THE PROVISION OF WATER SERVICE

WHEREAS, the Chiriaco Summit Water District (the District) has the authority to construct, operate, and maintain its water facilities; and

WHEREAS, the District has the authority to set rates for water service and collect such charges, as defined in the Article 9, sections 1 to 16 of its code of Rules and Regulations, as adopted on July 1, 2003; and

WHEREAS, the District is required to collect enough revenue to cover the costs of operating its water system, to be able to safely and reliably provide water to the residents and businesses of its service area, and to cover all the operating expenses, debt servicing, capital improvements, and other costs associated with providing safe drinking water for its customers, in accordance with applicable laws; and

WHEREAS, the District determined the current rate structure will not support the current and future costs of the system, and may also be potentially out of compliance with Prop 218 guidelines; and

WHEREAS, the District undertook a water rate study completed by Rural Community Assistance Corporation (RCAC) to modify the current tiered rate system implemented in 2016; and

WHEREAS, the District had enough water use and income and expenses historical data to properly calculate the cost of providing the service, and it was determined that the recommended rates do not exceed the reasonable cost of providing water services, and as such, the proposed rates are not levied for general revenue purposes; and

WHEREAS, the District's Board of Directors held a special meeting on September 24, 2024, to analyze the Water Rate Study Report provided by RCAC, and a second special meeting on December 17, 2024, to review the information and approve the start of the Prop 218 process to propose a rate change based on the study's findings; and

WHEREAS, on November 1, 2024, the District distributed by direct mail and posted in the District's Field office and other conspicuous places, notices of the public meeting to be held on December 17, 2024. The district held public meetings in order to collect public comments about the proposed rate system, as required by Proposition 218 (Cal Const. Art. XIIID, § 6).

**WHEREAS**, the Information included in the Public Notice includes proposed new rates, when the new rates would take effect, how property owners or water customers can protest the rate increase, and what the time frame for protests is, and when the public meeting for protest is scheduled; and

WHEREAS, after reviewing the public comments, the District Board's Secretary reported that there was not a majority protest of the proposed billing system by the owners or authorized agents of the owners of the accounts serviced by the District;

**NOW, THEREFORE, IT BE HEREBY RESOLVED** by the District, pursuant and subject to all of these facts, as follows:

**SECTION 1. SCOPE OF THE NEW RATE SYSTEM** – The proposed rate system will not affect the current rates for untreated water sales.

**SECTION 2. ADOPTION OF WATER RATES** – CSWD water rates are based on meter size and how much water is used. The proposed rate structure for water services has two components: (1) a **fixed monthly base charge**; and (2) a **variable (water consumption-based) usage rate**. The first component is a fixed amount calculated to recover the CSD's fixed costs of operating and maintaining the water system and is based on the potential volume of water a customer could draw, as determined by the size of their water meter. The variable component of the rate structure is based on water consumption. The variable usage rate will be charged from the first cubic foot of water purchased.

Water rates will increase over a five-year period instead of a large one-time adjustment.

The following water rates are hereby adopted and shall hereafter be charged to the customers of the District:

The above Base Charges and Usage Rates would go in effect with the first billing after the rates are approved. The rates will further increase on January 1, 2025. 2026, 2027, 2028, and 2029.

The base charge for initial bills and closing bills will be prorated on a daily basis.

**SECTION 3. EFFECTIVE DATE** – It was decided by the District Board of Directors, that this Resolution takes effect immediately, and the first billing cycle under the new regime to be distributed on January 1, 2025.
