Chiriaco Summit Water District (from now on, CSWD) Collection Policy is as follows:

Your monthly water bill will be available on the first five working days of the month following the billed month, at the CSWD's office. It will be either mailed or emailed to you according to your preferences, Your payment must reach CSWD's office by the 15th of the month (or the next business day) to avoid a late fee.

A late fee of \$20.00 will be charged to your account if the payment in full of your balance is not covered by the 16th of the month. If by the 20th of the month we have not received the billed amount plus the assessed late fee, you will be served a notice of balance past due. If at the first of the next month you have not paid your balance in full, your service may be subject to disconnection without further notice and a payment in full, including late fees will be needed to restore the service.
